The Relocation Appeals Board hears all complaints relating to relocation brought by persons displaced by City action. In those cases relating to redevelopment projects, the Board shall determine if the Redevelopment Agency has complied with specified provisions which relate to relocation and also, where applicable, federal regulations. The Board shall, after a public hearing, transmit its finding and recommendations to the City Council, or, in those cases relating to a redevelopment project, to the Redevelopment Agency.

Mr. Mooney will be reappointed for a term expiring October 1, 2010. I ask that you join me in thanking Mr. Mooney for his continued willingness to serve the citizens of San Diego in this capacity.

WHEREAS, the Relocation Appeals Board is to be comprised of five members who serve without compensation, appointed by the Mayor and confirmed by the City Council; and


