SUBJECT : Appointment and Reappointment to the Housing Commission

It is with pleasure that I appoint Allen Sims, and reappoint Khadija Basir to the Housing Commission, subject to your confirmation.

Allen Sims retired in 1996 after serving for 16 years as a Nuclear Security Officer for Southern California Edison at San Onofre Nuclear Generating Station. Mr. Sims handled security matters under the auspices of the U.S. Nuclear Regulatory Commission (NRC). After retiring from Southern California Edison, he worked for Securitas as a Security Officer from 2000-2007. Over the last five years, Mr. Sims has also served as an usher for San Diego Theatres and has provided assistance for numerous artistic performances at the San Diego Civic Center and the historic Balboa Theatre. Mr. Sims holds an Associate of Arts degree in Business from Pasadena City College. He also obtained a Real Estate Brokers License and sold residential properties for 14 years.

Mr. Sims honorably served in the military, and is passionate about serving others and the community. He served in the U.S. Army from 1962-1965, and National Guard from 1965-1968. Since 1973, he has given his time, talents, and resources as a member of the Free and Accepted Masons of Oceanside-San Dieguito Lodge #381, and has also been a member of the Scottish Rite of Freemasonry since 1974. Mr. Sims resides in Linda Vista. He will serve as the designated tenant of a Housing Authority unit who is over the age of 62, and will replace Alice Tumminia, who has resigned, for a term ending January 2, 2010.

I ask for your confirmation of this appointment to the Housing Commission, and that you join me in thanking Mr. Sims for his willingness to serve the citizens of San Diego in this capacity.

DATE OF FINAL PASSAGE _____

WHEREAS, the San Diego Housing Commission is established in San Diego Municipal Code section 98.0301 to act as a Housing Commission under the Housing Authority Law of the State of California; and

WHEREAS, the San Diego Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the San Diego Municipal Code also provides that of the seven members appointed by the Mayor, two commissioners appointed shall be tenants of Housing Authority units and at least one commissioner so appointed shall be over 62 years of age; and

WHEREAS, the term of office of each member shall be four years, except that the terms of office of the two members who are tenants of Housing Authority units shall be two years as set forth in section 34272 of the Health and Safety Code of the State of California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointment and reappointment by the Mayor of the City of San Diego to serve as members of the San Diego Housing Commission, for terms ending as indicated, be and the same are hereby confirmed:
