WHEREAS, for eighteen years, Michael Dudley has been a volunteer at Auntie Helen's Fluff 'n Fold, an organization that provides free laundry pick-up and delivery service to people with HIV/AIDS in San Diego; and

WHEREAS, for thirteen years, Michael Dudley volunteered with Pets Are Wonderful Support, an organization that provides essential services to assist the low-income elderly, chronically ill and disabled in keeping their companion animals; and

WHEREAS, Michael Dudley coordinated the AIDS Foundation of San Diego's Buddy Program, which matched HIV-positive and HIV-negative people for social activities, hospital visits and emotional support; and

WHEREAS, Michael Dudley volunteered with Special Delivery of San Diego, an organization that delivers nutritious meals to men, women and children living with HIV/AIDS and other life-threatening illnesses; and

WHEREAS, in addition to delivering meals, Michael Dudley also collected bread and perishables from Vons to distribute to people living with HIV/AIDS; and

WHEREAS, Michael Dudley served as Executive Director of Something Special Food Pantry, now known as Mama's Pantry and served as Housing Chair at the Pacto Latino Aids Organization; NOW, THEREFORE,
