SUBJECT	:	Appointments to the Housing Commission

It is with pleasure that I appoint Gary Gramling and Sam Guillen to the Housing Commission, subject to your confirmation.

Sam Guillen has more than 16 years experience in the Southern California housing industry. He began his career in 1992 in Downey, California participating in all aspects of real estate management and sales. In 2006, Mr. Guillen established his own full-service real estate company, Sam Guillen & Associates, and continues to be an innovative leader in the real estate market. He is particularly known for his expertise and insight into sales planning, market penetration, and asset disposition. As Broker/Owner of Sam Guillen & Associates, Mr. Guillen oversees all sales and business development functions including price opinions, account management, contract negotiations, and property management fulfillment, and actively participates in assisting first-time home buyers. WHEREAS, the San Diego Housing Commission is established in San Diego Municipal Code section 98.0301 to act as a Housing Commission under the Housing Authority Law of the State of California; and

WHEREAS, the San Diego Municipal Code provides that the Commission shall consist of seven members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the San Diego Municipal Code also provides that, of the seven members appointed by the Mayor, two commissioners appointed shall be tenants of Housing Authority units and at least one commissioner so appointed shall be older than 62; and

WHEREAS, the term of office of each member shall be four years, except that the terms of office of the two members who are tenants of Housing Authority units shall be two years, as set forth in section 34272 of the Health and Safety Code of the State of California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the following appointments by the Mayor to serve as members of the San Diego Housing Commission, for terms ending as indicated, be and the same are hereby confirmed:
