Leonard, Dick Murphy, Michael Richard Pent, Philip R. Pryde, Ibrahim Khoury Salameh, S. Tamzen Stephens, Edward P. Williams, and Henry Wilson. It was announced that John F. Pilch had withdrawn.

The following six finalists were selected by the Councilmembers on the first round of balloting: Dorothy Leonard, Dick Murphy, Michael Pent, Henry Wilson, Gerald Baker, and Hank Davenport-Barberis.

Mayor Wilson announced that the final selection would be made at the Special Council Meeting, 8:30 a.m. Tuesday, December 16, 1980.
