Peter B. Stafford withdrew his candidacy for the appointment to fill the vacancy for District 3.

Candidates Bill Brierton, Susan Golding, Robert Magness, Gloria Demers McColl, and Rachel Murguia Wong answered questions presented by the Councilmembers.

It was determined that the candidate receiving five votes would be selected.

The first ballot was taken, and Clerk Abdelnour announced the tally for Round 1: Golding-4, McColl-1, Wong-3.

The second ballot was taken, and Clerk Abdelnour announced the tally for Round 2: Golding-4, McColl-1, Wong-3.

The third ballot was taken, and Clerk Abdelnour announced the tally for Round 3: Golding-4, McColl-1, Wong-3.

The fourth ballot was taken, and Clerk Abdelnour announced the tally for Round 4: Golding-4, McColl-1, Wong-3.

The fifth ballot was taken, and Clerk Abdelnour announced the tally for Round 5: Golding-3, Magness-1, McColl-1, Wong-3.

The sixth ballot was taken, and Clerk Abdelnour announced the tally for Round 6: Golding-4, McColl-1, Wong-3.

Motion by Mitchell to adopt a rule eliminating candidates with less than 2 votes. Second by Murphy. Failed by the following vote: Yeas-1, 5, 7, M. Nays-2, 4, 6, 8. Not present-None. District 3 vacant.
