ITEM-334: (O-83-92) INTRODUCED, TO BE ADOPTED NOVEMBER 22, 1982

Introduction of an Ordinance amending the San Diego Municipal Code by amending Chapter X (Planning and Zoning Regulations), Article 1, Division 5, Section 101.0502 to allow the Zoning Administrator to increase the limited relief available through the Zone Variance or Reconstruction Permit procedure by not requiring a noticed public hearing for residential rehabilitation projects located in City-designated Neighborhood Improvement Areas. This would apply where the modification of distance or area regulations does not exceed 50 percent of required front, side, or rear yard nor exceed 20 percent of maximum lot coverage regulations.

3) - Repealing the existing land use zones within the proposed Barrio Logan Planned District.

4) - Amending the Barrio Logan/Harbor 101 Community Plan and Local Coastal Program Land Use Plan in order to incorporate Coastal Commission conditions with respect to public access, off-street parking guidelines, and sign guidelines.

The proposed Barrio Logan Planned District would be generally bounded by Commercial Street on the north, I-5 on the east, Division Street on the south and the Mean High Tide Line (Port District) on the west.

The Barrio Logan Planned District Ordinance is intended for use in implementing the Barrio Logan/Harbor 101 Community Plan, adopted by City Council Resolutions R-223842 and R-223843 in June 1979. The purpose of the Planned District is to meet the goals and objectives of the adopted Community Plan.
