Both the approved and proposed project sites are generally bounded by State Route 163 on the west, Camino de la Reina and Camino del Rio North on the south and Friars Road on the north, and extend approximately 700 feet east of I-805.

The approved Development Agreement permits the construction of a flood control channel, other public improvements and adjacent private development, including residential, office, retail, hotel and other uses. The development would be permitted over a 20-year period in accordance with the approved Specific Plan.

The proposed amendment to the Development Agreement and Specific Plan would alter the alignment of the flood channel, add the 46-acre Hazard Center private development north of the floodway, including office, retail and residential uses, and increase the number of residential units south of the river. The amendment would also increase the time permitted for submittal of a financing plan to the City for funding of public improvements.
