ITEM-601: (R-84-245) ADOPTED AS RESOLUTION R-259146

Authorizing the execution of an operating agreement for the Gaslamp Quarter Redevelopment Project with the Redevelopment Agency of the City of San Diego; authorizing the City Auditor and Comptroller to establish a special fund for City personnel costs incurred in support of the above project.

(Centre City Community Area. District-8.)

CITY MANAGER REPORT:

A redevelopment plan for the Gaslamp Quarter was adopted on July 26, 1982. The proposed agreement provides that any costs which the City incurs for project implementation and directly benefit redevelopment of the area would be paid by the Redevelopment Agency. In this regard, the City appropriated to the Agency \$3,235,545 for project implementation on February 8, 1983. Upon execution of this agreement, the City Auditor and Comptroller will establish a special fund for personnel costs incurred in support of the project. This action has been reviewed by the Gaslamp Quarter Council and is recommended for Council approval.
