SUPPORT WILL COME FROM THE PLANNING DEPARTMENT, SOUTHEAST
ECONOMIC DEVELOPMENT CORPORATION AND HOUSING COMMISSION.
DESIGNATE PLANNING DEPARTMENT TO SERVE AS LEAD AGENCY.
DESIGNATE SEDC WITH PLANNING DEPARTMENT INPUT TO HIRE THE
CONSULTANT BY JULY 1, 1984.

AT (2) JOINT DEVELOPMENT INTER-AGENCY AGREEMENT AND PROJECT,

BE A COST OF \$100,000, AND THE CONSULTANT OR PROJECT MANAGER TO

HIRED BY JULY 1, 1984, THE ACTION PLAN AND TIME TABLE COMPLETED
BY AUGUST 1, 1984, AND REDEVELOPMENT PLAN APPROVED BY COUNCIL
BY THE FIRST TUESDAY IN APRIL 1985.

(3) TEN YEAR ALLEY AND STREET IMPROVEMENT AND FINANCING
PLAN, AT A COST OF \$50,000 FOR CONSULTANT WITH THE ENGINEERING
AND DEVELOPMENT DEPARTMENT SERVING AS A LEAD AGENCY.

TO BE COMPLETED BY JANUARY 31, 1985. ALSO, \$250,000 FOR
FUNDING ALLEY IMPROVEMENTS IN CDBG HOUSING REHABILITATION

DEVELOPMENT DEPARTMENT WOULD SERVE AS LEAD AGENCY.

COST OF \$548,000 TO COMBAT ZONING AND CODE VIOLATIONS WITH
HOUSING COMMISSION SERVING AS LEAD AGENCY, THE CITY MANAGER,
WITH THE CITY ATTORNEY, HOUSING COMMISSION, AND BUILDING
INSPECTION, IS REQUESTED TO EXPLORE WAYS TO PARTIALLY OR

FULLY

RECOVER PROGRAM COSTS, AND TO SUBMIT A REPORT TO THE PS&S
COMMITTEE WITHIN FOUR WEEKS.

(5) LANDSCAPE AND BEAUTIFICATION FUND, AT AN INITIAL COST OF
\$82,600 AS SEED MONEY FOR LANDSCAPING PROJECTS NOT INCLUDING
THE EASTLINE TROLLEY PROJECT WHICH SHOULD BE FUNDED VIA JOINT
DEVELOPMENT EFFORTS.
