FINDINGS MUST BE MADE AS A PART OF COUNCIL ADOPTION

Determining and declaring that the public interest,

convenience and necessity of the City of San Diego requires

the development of the San Clemente Addition "A" Open Space Program in portions of Pueblo Lots 1243 and 1244 of the Pueblo Lands of San Diego and that the public interest, convenience and necessity demand the acquisition of fee title to said property for said San Clemente Addition "A" Open Space Program; declaring the intention of the City to acquire said property under eminent domain proceedings; directing the City Attorney to commence an action in the Superior Court of the State of California, in and for the County of San Diego, for the purpose of condemning and acquiring said property.

- 4) Amending Municipal Code Chapter X, Article 1, Division 4, Section 101.0454, the Hillside Review Overlay District, by adding further findings of fact in the review process, and adding Hillside Design and Development Guidelines for

both urbanizing and urbanized communities.

Introduction and adoption of an Ordinance amending Ordinance O-16249 (New Series), as amended, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 1984-85 and Appropriating the Necessary Money to Operate the City of San Diego for said Fiscal Year" by amending Document No. 00-16249-1, as amended and adopted therein, by amending Section 2.II thereof to add a new Subsection 35 entitled, "Hillcrest Parking and Business Improvement District Fund (10565)" to provide funds for the purposes of the District.
