The Museum requested the City to participate 50:50 in complete restoration of the Administration Building, adjacent to the Museum of Man in Balboa Park. This would entail a commitment of \$621,000 over a 3-year period if no grant funds were obtained for the project, or \$210,000 over 2 years if maximum grant funds were obtained. The Museum's request on September 25, 1985 exceeded its original request to PF&R on September 11, 1985 which was for \$70,000 in City funds to participate 50:50 in a smaller grant application. PF&R moved to sponsor the grant application on the Museum's behalf and to authorize the expenditure of an amount not to exceed \$70,000 from CIP-21-085.0 for the purpose of partial restoration of the Administration Building, Balboa Park.
