MOTION BY PRATT TO REFER ALL THE ISSUES TO THE RULES COMMITTEE CONSULTANT WHO IS TO MAKE AN ASSESSMENT AND REPORT TO THE RULES COMMITTEE FOR DISCUSSION AND PARCELING OF THE ISSUES AND POTENTIAL SOLUTIONS TO THE APPROPRIATE COMMITTEES AND CITY MANAGER. THEREAFTER, THE APPROPRIATE COMMITTEES AND CITY MANAGER ARE TO SUBMIT QUARTERLY PROGRESS REPORTS TO THE CITY COUNCIL. IT IS RECOMMENDED THAT THE SAME LEVEL OF ORGANIZATION, EFFORT, AND FUNDING THAT SPARKED THE DOWNTOWN REDEVELOPMENT BE EXTENDED TO COMMUNITIES SUCH AS BARRIO LOGAN, SHERMAN HEIGHTS, AND SAN YSIDRO. IT IS SUGGESTED THAT THE CITY AND THE CITY SCHOOLS WORK TOGETHER TO IMPROVE THE COOPERATION OF EFFORTS. Second by Struikma. Passed by the following vote: Wolfsheimer-not present, Roberts-yea, McColl-not present, Pratt-yea, Struikma-yea, Henderson-not present, McCarty-yea, Filner-yea, Mayor O'Connor-yea.
