CITY MANAGER SUPPORTING INFORMATION:

The proposed vacation has been initiated by the submission of a tentative map for Cypress View Estates (TM-88-0542). The subject vacation and tentative map area are located within the Scripps Miramar Ranch community and within the R-3000 Zone. The tentative map proposes subdivision of 12.47 acres into 25 lots for single-family residential use and one lot for future commercial development. Future development of the residential segment will be controlled by the related Planned Residential Development Permit (PRD-88-0542). There are no development plans for the commercially designated property at this time. The Subdivision Board recommended approval of the tentative map and street vacation on January 3, 1989.

The subject vacation consists of two excess portions of the old alignment for Pomerado Road which are now closed to through traffic. The new alignment for Pomerado Road was dedicated recently with the Sunburst Scripps and Scripps Eastview Projects (TM-87-0883 and TM-88-0884 respectively). The future improvements will also be provided with those developments. The area-of-vacation totals 0.783 acres of which 0.336 acres will be utilized with the residential development and 0.447 acres will be consolidated with the future commercial property. Easement

reservations are not required since all necessary easements will be provided with the final map.

Staff review has indicated that the excess rights-of-way are no longer required for present or prospective public use and may be summarily vacated conditioned upon the recordation of the final map for Cypress View Estates (TM-88-0542).
