Motion by Wolfsheimer to direct the City Manager to find a way to immediately purchase the property that is to be designated for open space, set up a transferrable development rights system so that the task force could take a look at using that as a means of acquisition, and set up a financing system. Bring back to Council so it can dovetail with the report on the FUA framework due back on November 17, 1992. Second by Stallings. Passed by the following vote: Yea-1,2,3,4,5,6,7; Nay-None; Not present-8,M.

Motion by McCarty to direct the City Manager to revise the language in the amendment coming back to Council related to the density of Professor Hue's property as low density and bring back in two weeks to incorporate specific direction related to this property. Failed by the following vote: Yea-2,3,5,7; Nay-1,4,6; Not present-8,M.

Subitem-A: DELIBERATIONS CONTINUED

Continuing deliberations on the Fiscal Year 1993 City Budget. The meeting of October 1 included: City Manager's Overview, proposed General Fund Budget Reductions, Proposed Revenue Increases, Transient

Occupancy Tax Transfer. In addition to continued deliberations on these issues, today's meeting may also include the Clean Water Program - Revised Budget and Water Utilities Department - Revised Budget.

Directing the City Manager to prepare an amendment to the Fiscal Year 1993 Annual Appropriation Ordinance based on City Manager Report CMR-92-288 which reflects (1) changes due to reduced revenues from the State and a shortfall associated with the depressed economy, (2) up to \$950,000 in reductions to the Building Inspection Department due to the sluggish economy, (3) a revised Clean Water Program Fiscal Year 1993 budget made necessary by Judge Brewster's interim order of July 10, 1992, and (4) a revised Water Utilities Department Fiscal Year 1993 Budget; approving \$2,900,000 in reductions to the Redevelopment Agency.
