# Subitem-A: (R-93-721)

Approving the legislation in the PLAN B: Police Initiative petition and directing the City Attorney to prepare a resolution containing the legislation for the purpose of putting it in the proper format for amending the Progress Guide and General Plan of the City of San Diego for adoption by the City Council; or Subitem-B: (R-93-722)

Rejecting the legislation contained in the PLAN B: Police Initiative petition.

CITY CLERK SUPPORTING INFORMATION: Representatives of PLAN B: PLAN Police Initiative, Inc. have filed an initiative petition entitled "The PLAN B Police Initiative" with the City Clerk's office. On October 26, 1992, The Registrar of Voters completed the petition signatures verification by use of the random sampling method authorized by the San Diego Municipal Code. The petition was found to contain 21,622 signatures.

In order to qualify an initiative petition for submittal to the voters, it must contain signatures of at least ten percent (10%) of the city's registered voters. The current requirement is 55,153 signatures. The petition is therefore insufficient to cause direct submission to the people.

The submitted petition does contain the signatures of at least three percent (3%) of the voters, which is currently 16,546 required signatures. Pursuant to Municipal Code Section 27.2520 this petition therefore qualifies for presentation to the City Council.

Municipal Code Section 27.2520 provides that "If the petition presented to the Council contains the signatures of at least three percent but less than ten percent of the voters, the Council must within ten days approve or reject the legislative act as presented but may not amend it."
