CITY MANAGER'S RECOMMENDATION:

Rejecting all bids received on August 12, 1993, and readvertising for bids for Construction of Palisades Building Roof Repairs on Work Order No. 119269;

Authorizing the execution of a contract with the lowest responsible bidder. (BID-K3614/93B)

#### CITY MANAGER SUPPORTING INFORMATION:

The Palisades Building is located at 2130 Pan American Plaza in Balboa Park. It is just north of the Automobile Museum. This contract will replace the roof on the entire building. Bids for the Palisades Building Roof Repairs project were received on August 12, 1993. The low bid of \$156,146 was submitted by Morrison-Hope Roofing Company. This company failed to demonstrate its good faith effort in complying with the City's MBE/WBE Program goals. Therefore, it is recommended that all bids be rejected.

SUBJECT: Actions related to implementation of The Cable Television Consumer Protection and Competition Act of 1992 (Cable Act of 1992).

#### CITY MANAGER'S RECOMMENDATION:

Adopt the following resolution:

(R-94-326 Rev.1) ADOPTED AS AMENDED AS RESOLUTION R-282742

Designating the City Public Utilities Advisory Commission ("CPUAC") to serve as the advisory hearing body concerning proposed cable television customer service obligations and requesting the CPUAC to establish appropriate hearing procedures for this issue, conduct hearings, and report its recommendations to the City Council;

Authorizing the City Manager and City Attorney to notify the City of San Diego's cable television franchisees of the City's intention to enforce customer service obligations adopted by the Federal Communications Commission ("FCC") as an interim measure;

Adopting the initial findings required by "The Cable Television Consumer Protection and Competition Act of 1992" for certification to regulate basic cable service rates and authorizing the City Manager and City Attorney to apply to the FCC for certification;

Directing the cable franchisees within the City to

present evidence to establish reasonableness of rates set for basic cable service within the time called for in the FCC regulations;

Authorizing the City Manager and City Attorney to work with the County of San Diego to determine if there are opportunities to consolidate cable television regulation efforts.

COMMITTEE ACTION: Reviewed by Rules on 9/13/93. Recommendation to accept in concept the Manager's recommendations; schedule a special Council meeting for September 27, 1993 to hear public testimony; refer to Council on/or before October 12, 1993 for final action following the meeting of September 27. FINDINGS MUST BE MADE AS PART OF COUNCIL ADOPTION.

Determining and declaring that the public interest, convenience and necessity of the City of San Diego require the construction, operation and maintenance of

a public street or streets with right-of-way for the right of ingress and egress over, under, along, and across, portions of parcels lying between San Ysidro Boulevard (formerly Tijuana Boulevard) and Bolton Hall Road;

Declaring that the public interest, convenience and necessity demand the acquisition of fee title to the property for right-of-way required for construction of San Ysidro Boulevard - Smythe Avenue to Border Village Road;

Declaring the intention of the City of San Diego to acquire the property under eminent domain proceedings;

Directing the City Attorney to commence an action in the Superior Court of the State of California, for the purpose of condemning and acquiring the property and easements.
