CITY MANAGER'S RECOMMENDATION:

Adopt the following resolutions:

Subitem-A: (R-95-1274)

Authorizing an amendment to the reimbursement agreement of April 23, 1990, with Pardee Construction Company, for the design and construction of Hage Neighborhood Park;

Authorizing the reimbursement of an amount not to exceed \$1,000,000 from FBA Fund 79006, CIP-29-292.0.

Subitem-B: (R-95-1275)

Stating for the record that the information contained in Environmental Negative Declaration DEP-87-0456, has been reviewed and considered by the Council for the City as Lead Agency in connection with Hage Neighborhood Park.

### CITY MANAGER SUPPORTING INFORMATION:

The City Council, on April 23, 1990, approved a Reimbursement Agreement with Pardee Construction Company (Pardee) for design and construction of five acres of nine acre Hage Neighborhood Park (Project). The estimated cost was \$500,000, payable in FBA credits or cash. Pardee has completed the project and the actual total project cost is \$1,000,000 due to revisions which significantly increased the scope of work. The approved General Development Plan (GDP) for the entire nine acre site was redesigned three times at different phases of the project based on input from public hearings. The changes that were requested by planning agencies and public groups required revisions to the plans and specifications needed for construction of the project. The project construction plans were completely redrawn to provide a joint use parking lot with Hage Elementary School, requiring a reconfiguration of the park layout, and increasing the project

area and work to be done. The project construction cost of \$650,000 alone exceeded the original total project estimate of \$500,000. The balance of \$350,000 was expended for professional services and project administration costs.

HOUSING COMMISSION'S RECOMMENDATION:

Adopt the following resolution:

(R-95-1245) ADOPTED AS RESOLUTION R-285508

Adopting the 1991-98 Housing Element Update, covering the period July 1, 1991 to June 30, 1998, as an amendment to the City's Progress Guide and General Plan;

Directing that notice and a copy of the Housing Element Update document be forwarded to the California Coastal Commission recommending that the amendment to the City's Progress Guide and General Plan be incorporated into the Local Coastal Program;

Declaring that the San Diego Housing Commission has responsibility for any future updates or annual reports pertaining to the Housing Element;

Directing the San Diego Housing Commission and affiliated agencies to pursue activities described within the 1991 Housing Element Update, including those

which require presentation of policy recommendations to the City Council for consideration.

## SUPPORTING INFORMATION:

On July 1, 1991, in accordance with State law, the City was required to update the Housing Element of its General Plan. April 1992, the City Council authorized submission of a draft of the 1991 Housing Element Update to the State Department of Housing and Community Development (HCD). In June 1992, HCD responded to the City's submission with a list of findings. Between June 1992 and November 1994, the City, with the Planning Department as the lead, worked with HCD to address the findings. In Fall 1994, because the San Diego Housing Commission is responsible for preparing the City's federally-mandated housing plan, it was also given responsibility for the City's Housing Element. In November 1994, a civil suit was filed in Superior Court of the State of California, County of San Diego (Case No. 68290, Kevin Hoffmaster et al. v. City of San Diego et al.) on behalf of homeless persons claiming that San Diego is in violation of State law because it does not have a certified 1991 Housing Element Update thus, it was argued, the City has not demonstrated, pursuant to Government Code Section 65580, that it has sufficient sites to accommodate the housing needs of all income groups, particularly the homeless. On December 16, 1994, the judge, pursuant to Government Code Section 65754, ordered the City to bring its Housing Element into compliance with State law within 120 days. In response to the court order, the City Council, on January 17, 1995, directed the San Diego Housing Commission to submit a revised draft of the City's 1991 Housing Element Update to HCD. The document was received by HCD on January 23, 1995 and, pursuant to Government Code Section 65754, HCD was given 45 days from that date, or until March 9, to complete a review. On February 24, 1995, HCD notified the San Diego Housing Commission that it has certified the City's 1991 Housing Element Update as substantially complete. This action clears the way for City Council adoption of the 1991 Housing Element.

### ENVIRONMENTAL IMPACT:

On January 18, 1995, the City completed an Initial Study of the 1991 Housing Element Update, pursuant to Government Code Section 65759. The results of the study determined that the Housing Element, while identifying the housing needs of existing and future residents, does not, in and of itself, result in the development of specific housing projects. Therefore, it is determined that no significant environmental impact would result from adoption of the City's 1991 Housing Element Update.

IT IS THE COUNTY AND THE BOARD OF SUPERVISORS' RESPONSIBILITY TO PROVIDE THE NEEDS OF THE HOMELESS WITHIN THE CITY OF SAN DIEGO AS WELL AS WITHIN OTHER CITIES THROUGHOUT THE COUNTY OF SAN DIEGO. THIS MEETING SHOULD BRING TOGETHER THE EFFORTS OF THE CITY AND COUNTY SO THAT THERE IS NO DUPLICATION AND SO THAT THE COUNTY FULFILLS ITS RESPONSIBILITY TO THE CITIZENS OF SAN DIEGO. Directing the City Attorney and City Manager to take action as necessary, including the selection of bond counsel and financial advisors, to prepare the necessary documentation for Council consideration at the time the election ordinance for the September 1995 Special Election ballot is considered; Approving the contribution of \$10 million from the Redevelopment Agency for the Central Library to be sited downtown.

MOTION BY McCARTY TO CONTINUE TO MAY 2, 1995. IF COUNCIL DECIDES TO PUT THE LIBRARY ON AS A SPECIAL ELECTION, THEY WILL TRY TO OFFSET THE COST WITH PRIVATE SOLICITATION. DIRECT THE CITY MANAGER TO PROVIDE THE FOLLOWING INFORMATION AT THE EARLIEST POSSIBLE MOMENT:

- 1. AGGRESSIVELY PURSUE THE TWO OPTION POSSIBILITIES THAT WERE PRESENTED TO COUNCIL BY PETER HALL AND BARRY MCCOMMICK FOR AN INTERJURISDICTIONAL PARTNERSHIP BETWEEN CCDC, THE PORT AND THE CITY IN THE FOLLOWING TWO WAYS: A) LOOK AT WHETHER WE CAN BE SPECIFIC ENOUGH TO KNOW THAT IT WILL HAPPEN BEFORE THE END OF MAY, AND I WOULD URGE BEFORE THE FIRST OF MAY; B) SEE WHAT PORTION OF THE COSTS COULD BE DEFRAYED BY A PUBLIC/PRIVATE PARTNERSHIP SO THAT COUNCIL WILL HAVE A BETTER IDEA OF WHAT THE BOND MEASURE WILL CONSIST OF SHOULD THEY CHOOSE TO PUT A BOND MEASURE ON IT FOR EITHER 1995 OR 1996;
- 2. ASK THE CHAIR OF THE LIBRARY COMMISSION TO HOLD PUBLIC HEARINGS WITH REGARD TO THE LIST OF BRANCHES. A PUBLIC HEARING WILL THEN BE HEARD IN COMMITTEE BEFORE IT RETURNS TO COUNCIL.
- 3. PROVIDE THE FOLLOWING: 1) THE CRITERIA, REASONS, AND COMPARISON OF ABUSES ON THE LIBRARIES SELECTED IN CASE COUNCIL WISHES TO MAKE ANY CHANGES; 2) THE COST OF THE SPECIFIC SITES THAT WE ARE LOOKING AT; 3) A BREAKDOWN OF THE

COST OF THE ELECTRONIC CAPABILITIES OF THE CENTRAL LIBRARY VERSUS THE COST OF THE ACTUAL CONSTRUCTION OF THE LIBRARY; AND 4) A BREAKDOWN OF THE COST TO HOOK UP THE BRANCHES ELECTRONICALLY AND TO IMPROVE THEM.

- 4. PROPOSE A WAY THAT WE CAN PAY FOR STAFF, FURNITURE, FIXTURES AND OPERATION OF THE NEW BRANCHES.
- 5. THE REPORT REFERS TO THE ACQUISITION OF PROPERTY FOR \$1.5 MILLION WITH REGARD TO SERRA MESA. IF THAT IS ALREADY CITY PROPERTY, THE \$1.5 MILLION NEEDS TO BE REPROGRAMMED. Second by Stevens. Passed by the following vote: Mathisyea, Harvey-yea, Kehoe-yea, Stevens-yea, Warden-yea, Stallings-yea, McCarty-yea, Vargas-yea, Mayor Golding-yea.
