Supporting the San Diego County Water Authority's Graywater Incentive Pilot Program, which will offer a \$260 incentive for installing graywater systems in new homes and provide the opportunity to evaluate graywater systems in terms of actual cost and water savings, and declaring that the City will contribute in-kind services such as meter reading and providing usage data, estimated at \$18,200 in staff time.

LAND USE AND HOUSING COMMITTEE'S RECOMMENDATION:

On 5/26/99, LU&H voted 4-0 to accept the City Manager's recommendation to participate in the County Water Authority (CWA) Graywater Pilot Project, and refer the issue of Graywater Recycling to the full City Council for discussion. (Councilmembers Wear, Stevens, McCarty, and Vargas voted yea. Councilmember Mathis not present.)

<u>CITY MANAGER SUPPORTING INFORMATION:</u>

The City of San Diego is committed to implementing proven water conservation programs. This commitment became evident when the City became one of the original signatories to the Memorandum of Understanding Regarding Urban Water Conservation in December of 1991. Since then the City has been proactive in implementing water saving measures and receptive to considering new technology that promotes long term water savings. On May 26, 1999, the Land Use and Housing (LU&H) Committee reviewed residential graywater recycling as a conservation method. City staff presented a cost analysis of these systems, the projected water savings, and other non-economic considerations of using graywater. Staff also described the proposed San Diego County Water Authority (CWA) Pilot Graywater

Incentive Program which will offer a \$260 incentive for installing graywater systems in new homes. This program will also provide the opportunity to evaluate graywater systems in terms of actual cost and water savings. The LU&H Committee approved the Manager's recommendation to participate in the CWA Program and moved to have this item presented to the entire City Council.

FISCAL IMPACT:

There is no financial contribution from the City to participate in this program. The City is expected to contribute in-kind services such as meter reading and providing usage data for program evaluation, estimated at \$18,200 in staff time.
