City Attorney Gwinn reiterated Noel Neudeck's concerns regarding the Bardon case which dealt with the ADA community. It concerned the issue of whether or not the City Council had taken action to be part of a lawsuit in Sacramento. The City Council has not taken any action. City Attorney Gwinn stated that first, the City Attorney reviews amicus brief requests from the State of California and throughout the country to support this position. The City had actually joined that case a year and a half ago per the request of the National League of Cities and the California League of Cities. Mr. Gwinn stated he has agreed to review that decision with representatives of the disabled community on December 12, 2002 in the City Attorneys Office. Thereafter, a decision will be made whether to continue to be involved in the amicus brief.
