**CITY MANAGER SUPPORTING INFORMATION:**

This Slurry Seal contract is part of the City's annual street maintenance program, and also includes some streets which have recently had overhead utilities placed underground. Slurry Seal is a pavement surface treatment applied as part of a comprehensive pavement maintenance program. It is used on streets which are in good condition to protect them from deterioration. The Street Division uses Rubberized Emulsion Aggregate Slurry (REAS). This type of Slurry Seal coating lasts longer, resists damage better from water/rain, and stays black in color longer. Slurry sealing, when used in a timely manner can be very effective in reducing the need for later, more expensive pavement repairs. The Street Division's portion of this contract provides for the sealing of approximately 32.5 miles throughout the city. Locations for Slurry Seal coating are chosen through the use of annual surveys, and the City's Pavement Management System, using the following criteria: age, oxidation, cracking, and amount of traffic carried. Accordingly, a preliminary list of locations has been identified. Due to ongoing construction city wide, the list of locations for this project will be finalized just prior to the start of the contract. Construction is expected to begin in July of 2004, and will take approximately two months.

In coordination with the Engineering and Capital Projects Department, this contract will also provide for the slurry sealing of 22 underground utility conversion projects citywide as well as the Del Mar Terrace Maintenance Assessment District. These projects are: B St. and C St. Phase I, B St. Phase II, Balboa Ave., CCDC Area 3 Phase I, CCDC Area 3 Phase II, Del Cerro Bl., Fort Stockton Dr., Goldfinch St., Jamacha Rd., Kelton Rd., La Jolla Mesa Dr. (Deerhill Dr.), La Jolla Mesa Dr. (Turquoise), La Jolla Shores, Orange Ave., Scripps Lake Dr., Silverado St., Stream View Dr., Sunset Blvd., West Point Loma Blvd., Zion Ave., and Del Mar Terrace (Maintenance Assessment District). The Mayor and Council will be provided with the final list of streets as soon as it is available.

**CITY MANAGER SUPPORTING INFORMATION:**

This project provides for a single unit comfort station at Lakeview Neighborhood Park in the community of Scripps Miramar Ranch. This is a heavily used park which is currently served by porta-potties. The community requested a permanent facility, therefore \$100,000 was originally programmed.

The original location that was proposed for this comfort station was the south side of the parking lot but was then relocated to the northeast corner of the lot to stay clear of the Multi Habitat Protection Area. In addition to the comfort station, the scope of work includes accessibility improvements to provide access from park and accessible parking to the proposed comfort station and utility hookups for electrical, water and sewer to the proposed building structure. The sewer connection also requires a pump due to the elevation of the parking lot relative to the sewer main in the adjacent street.

The bids were opened on April 27, 2004; the low bid was \$177,541 by CDM Construction Incorporated. The construction contract will be awarded pending this transfer of funds.

**FISCAL IMPACT:**

The estimated project cost is \$250,000 of which \$100,000 has been previously approved. The remaining funds are available in Scripps Ranch Special Park Fees, Fund No. 11230. The funds are coming from the Scripps Ranch Special Park Fees, Fund No. 11230, which are programmed for the Ahrens Field Improvements, Project 34-24, in the Fiscal Year 2003 Scripps Miramar Ranch Public Facilities Financing Plan. The Ahrens Projects are scheduled for Fiscal Years 2009-10. Due to a reduction in the Scope of the Ahrens Field Project, the funds have been made available for Lakeview Neighborhood Park. State law created in the State treasury an Indian Gaming Revenue Sharing Trust Fund and an Indian Gaming Special Distribution Fund. State Senate Bill 621 established methods and criteria for distributing these funds to local government agencies impacted by tribal gaming. In order to be competitive for these funds, applicants must be sponsored by a local gaming tribe. Representatives of local tribes have invited the San Diego Police Department to apply for the following:

- Command vehicle and equipment for coordination and communication in disasters, emergencies, and large-scale incidents and events: \$400,000
- Mounted Patrol resources, including horses, tack, truck and trailer to facilitate crowd control, rural/wildland access, search and rescue, evacuations, and other appropriate activities: \$151,000
- Emergency negotiation vehicle and equipment hostage, suicide, high-risk warrant, and similar activities: \$178,721
- Ballistic vests (120) for SWAT Team members: \$114,000

Total Requested:       \$843,721

Each of these is a critical safety and enforcement resource that SDPD has been unable to acquire or replace for many years, with the result that our existing equipment is worn, obsolete and inadequate. These grants provide an opportunity to enhance vital emergency equipment with minimal cost to the City.

It is anticipated that the Indian Gaming Local Community Benefit Committee will select the projects to be funded at the end of May 2004 and State Controller's Office will allocate the money to grant recipients by June 30, 2004. Only grant requests for projects that can be initiated soon after funding is allocated will be considered. Therefore, it is requested that approval of this Council Resolution be expedited.

SB 621 requires that grant recipients provide notice to the public, through slogan, signage or other mechanism, that the project has received funding from the Indian Gaming Special Distribution Fund, and identifying the particular Individual Tribal Casino Account from which the grant derives. This requirement will be met through discreet signage attached to equipment where feasible, and through media releases.

**FISCAL IMPACT:**

There is no requirement for matching funds, and no requirement to continue grant funded activities or expenditures after grant funds are exhausted or terminated. The San Diego Police Department will assume all ongoing maintenance and operation costs from the existing budget. However, in many cases ongoing costs will be offset by the greater reliability and efficiency of the new equipment compared to the old.

On May 20, 2003, the City Council approved Contract Change Order #3, which reduced the contract by \$1,000,000 due to a reallocation of AB 2928 funds from the State of California. On June 17, 2003, the City Council approved Contract Change Order #4, which increased the amount of the contract by \$222,273.72 for resurfacing of streets in cooperation with the Engineering Department's Utility Undergrounding program. Contract Change Order #5 added \$194,417 for replacement of damaged sidewalks at 62 additional locations. On February 9, 2004, the City Council approved Contract Change Order #6, which increased the contract by \$245,051.50 for final paving related to Water and Sewer Group 539.

Contract Change Order #7 will provide for the re-paving of the entrance and access road to the Miramar Landfill and the City Metro Biosolids Center, as well as the final paving of five underground utility conversion projects citywide. This action will increase the contract by \$656,488.36 from \$4,022,845.15 to \$4,679,333.51.

**NATURAL RESOURCES AND CULTURE COMMITTEE'S RECOMMENDATION:**

On 5/12/2004, NR&C convened for discussion only. No action taken.

**CITY MANAGER SUPPORTING INFORMATION:**

Petroleum products have been discharged to the ground and ground water from the Mission Valley Terminal since 1986. The contamination now extends to the City-owned Qualcomm Stadium and beyond. In 1992, the Regional Water Quality Control Board issued a Clean Up and Abatement Order to Kinder Morgan Energy Partners and other potential responsible parties for this site. Kinder Morgan was ordered to propose an overall plan for remedial activity which was submitted to the Regional Board on February 3, 2004. This plan proposes various clean-up levels and clean-up milestone dates extending out to 2034.

The City of San Diego created a Working Group to evaluate the proposal, time schedules and the impacts to the City's future plans. Currently the City is planning for groundwater storage and extraction as part of a groundwater management program. The contamination must be remediated prior to 2007 in order for this project to meet its proposed time schedules. In addition, the remediation must be completed prior to any future redevelopment of the Qualcomm site.

Based on its evaluation of the proposal, the Working Group submitted a series of detailed reports and a proposed clean-up and abatement order to the Regional Board in advance of a public workshop held by Regional Board staff on May 3, 2004. At the workshop, the Working Group presented its materials and urged the adoption of an expedited clean-up order.

The Regional Board soon will be considering a new order for remediation of the site. This action will allow for a resolution of the City Council authorizing a letter to the RWQCB from the Mayor and Council requesting that the matter of a new order be heard by the Regional Board as soon as possible, but no later than August, 2004, and urging the adoption of a new clean-up and abatement order requiring clean-up on an expedited bases. The City is requesting that the remediation be expedited given that 15 years has transpired since the initial release was identified and the release continues to adversely impact significant public resources.
