Adopt the following resolution:

Subitem-A (R-2005-689) ADOPTED AS RESOLUTION R-300021

Declaring that in order for the City to facilitate its cooperation with current investigations by the Securities and Exchange Commission [SEC] and the U.S. Attorney, and to facilitate the work of the City's outside auditor, KPMG, the City Council authorizes Vinson & Elkins LLP to share with the SEC, the U.S. Attorney, and KPMG its memoranda of interviews conducted and to be conducted in relation to the audit of the City's financial statements for 2003:

Declaring that the City Council authorizes KPMG personnel to attend and participate in any such interviews.

Subitem-B (R-2005-690) ADOPTED AS RESOLUTION R-300022

Declaring that this City Council authorizes the City Manager to expend an amount not to exceed \$150,000 for the purpose of paying attorney's fees for any past and present City employees related to their participation in interviews or proceedings, including compliance with subpoenas served on any past or present City employee, related to the investigations by the Securities and Exchange Commission and U.S. Attorney, provided that the City Auditor and Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
