In this case SDCERS seeks a judicial declaration upholding the legality of benefits granted under MP I and MP II. Complaints in intervention have been filed by the various unions. Additionally, a separate complaint on the same issues was filed on behalf of 190 individual retirees, which has been consolidated with this case. The City Attorney's office has moved to consolidate this case with the first SDCERS case. That motion to consolidate will be heard on January 13, 2006. In closed session the City Attorney will update the Mayor and Council on the status of the matter.
