Amend the Fiscal Year 2005 Redevelopment Agency Budget by a) decreasing the City Heights Redevelopment project Area budget for the Model School project (Fund 98226) in the amount of \$60,000 to provide funds for the Euclid Avenue Gateway Project, and b) increasing the appropriation and authorizing the expenditure of up to \$60,000 in the City Heights tax increment and the transfer of the funds to the Capital Improvement Program Budget No. 52.699.0 for the Euclid Avenue Gateway Project.
