## 1. Third Rehabilitation Grant Agreement with the NTC Foundation (District 2)

Request that the Redevelopment Agency:

(<u>RA-2011-20</u>)(Cor.Copy)

- Item 1. Approve all of the terms and conditions in the proposed Third Rehabilitation Grant Agreement.
- Item 2. Authorize the Executive Director of the Agency, or designee, to execute the Third Rehabilitation Grant Agreement with the NTC Foundation for and on behalf of the Agency.
- Item 3. Authorize the City Chief Financial Officer, or designee, to appropriate and expend an amount not to exceed \$4.0 million from the NTC Redevelopment Tax Allocation Bonds Series 2010 A Tax Exempt proceeds (Fund #400697-NTC-TAC 2010A (TE) Proceeds), contingent on a Comptroller's Certificate to do so, to grant to the NTC Foundation for the rehabilitation of a portion of the Foundation's Phase 2 development costs.
- Item 4. Authorize the City Chief Financial Officer, or designee, to appropriate and expend an Additional Agency Grant, as defined in the Third Rehabilitation Grant Agreement, if NTC Redevelopment Project Tax Increment Funds are paid to the Agency from the County of San Diego as a result of property taxes generated within the Civic, Arts and Cultural Center and paid by the Foundation or its subsidiaries, contingent on a Comptroller's Certificate to do so.
- Item 5. Authorize the Executive Director of the Agency, or designee, on behalf of the Agency, to sign all documents necessary and appropriate to carry out and implement the Third Rehabilitation Grant Agreement and to administer the Agency's obligations, responsibilities and duties to be performed under the Third Rehabilitation Grant Agreement.

This activity is adequately addressed in a Mitigated Negative Declaration (Project No. 99-1076/SCH No. 2000081037, dated September 14, 2000) prepared for the Naval Training Center Precise Plan and Local Coastal Plan & Related Entitlements/MWWD Environmental Monitoring and Technical Services Laboratory and is part of a series of subsequent discretionary actions, and therefore not considered to be a separate project for purposes of CEQA review as defined in State CEQA Guidelines Section §15378(c). Pursuant to Section 15162 of CEQA, there is no change in circumstance, additional information or project changes to warrant additional environmental review.
