- Item 1. That the Redevelopment Agency of the City of San Diego ("Agency") approve the termination of the Owner Participation Agreement, as amended, with Constellation Property Group Hancock L.P. for the Stella at Five Points Housing Project due to failure to timely cure events of default under the Owner Participation Agreement.
- Item 2. That the Agency approve and authorize the Agency Executive Director, or designee, to take all reasonable and necessary actions and execute on behalf of the Agency all reasonable and necessary documents to implement and carry out the purposes of this Resolution and the termination of the Owner Participation Agreement including, without limitation, (i) the Notice of Termination of the Owner Participation Agreement, and (ii) the Release of Agreement Affecting Real Property.

This activity will not result in a direct or reasonably foreseeable indirect physical change in the environment and, therefore, is not subject to the California Environmental Quality Act ("CEQA") pursuant to CEQA Guidelines Section 15060(c)(2).

Housing Impact: If termination of the Owner Participation Agreement is approved, the Agency will initiate the release of the Agreement Affecting Real Property recorded against the Property on June 12, 2007 requiring 13 affordable for-sale housing units to be provided by the Project pursuant to the Owner Participation Agreement. The Project continues to be required to comply with the City of San Diego's Inclusionary Housing Ordinance.
