Fill out a speaker slip "In Favor" or "In Opposition" to the Recommendation listed first on the Docket for the subject item, and submit the form to the City Clerk. Speakers will be called by name to address the Redevelopment Agency when the item is heard. Time allotted to each speaker is determined by the Chair and, in general, is limited to three (3) minutes; moreover, collective testimony by those who support or oppose an item shall be limited to no more than fifteen (15 minutes to per side).

Members of the public wishing to address the Agency must submit a "Request to Speak" form to the City Clerk **prior** to the agenda item being called. Please note that "Request to Speak" forms will **not** be accepted once the item is called. Speaker slip on any item should be submitted at the **beginning** of each Agency meeting.

2. **Enforceable Obligation Payment Schedule (Districts 2, 3, 4, 6, 7 & 8)**

[\(RA-2012-7\)](#)

The proposed action calls for the adoption of an Enforceable Obligation Payment Schedule (“EOP Schedule”) that lists all of the Agency’s “enforceable obligations” as defined under ABx1 26. This action is immediately required by the Agency Board to be in compliance with State Law and a recent court order and amended court order of the California Supreme Court.

The proposed action is not a “project” within the meaning of the California Environmental Quality Act (CEQA), specifically CEQA Guidelines section 15378(b)(4)-(5), and thus not subject to CEQA pursuant to CEQA Guidelines section 15060(c)(3).
