Fill out a speaker slip "In Favor" or "In Opposition" to the Recommendation listed first on the Docket for the subject item, and submit the form to the City Clerk. Speakers will be called by name to address the Redevelopment Agency when the item is heard. Time allotted to each speaker is determined by the Chair and, in general, is limited to three (3) minutes; moreover, collective testimony by those who support or oppose an item shall be limited to no more than fifteen (15 minutes to per side).

Members of the public wishing to address the Agency must submit a "Request to Speak" form to the City Clerk **prior** to the agenda item being called. Please note that "Request to Speak" forms will **not** be accepted once the item is called. Speaker slip on any item should be submitted at the **beginning** of each Agency meeting.

1. **Fifth Amendment to the Agreement with the Law Office of Don Detisch for Legal Services (Litigation and Land Acquisition)–Centre City Redevelopment Project (District 2)**

Item 1. Approve the proposed Fifth Amendment to the Agreement between the Agency and the Law Office of Don Detisch to increase the maximum compensation by \$150,000, revise the Scope of Services, and extend the term through December 2012; and

Item 2. Authorize the City Chief Financial Officer, as delegated, to appropriate, encumber and expend Centre City Redevelopment Project Area tax increment funds not to exceed \$150,000.

This activity is not a “project” for purposes of the California Environmental Quality Act (CEQA) because it does not fit within the definition of a “project” set forth in Public Resources Code Section 21065 or State CEQA Guidelines Section 15378. Thus, this activity is not subject to CEQA pursuant to State CEQA Guidelines section 15060(c)(3).
