

MINUTES OF THE REGULAR MEETING OF THE

TUESDAY, APRIL 4, 1972

The Regular Meeting of the Redevelopment Agency of The City of San Diego, California, was called to order at 3:07 p.m.

Minutes of the Regular Meeting of Tuesday, March 7, 1972, were presented by the Deputy Secretary. On motion of Member Landt, said Minutes were approved without reading, after which they were signed.

Jim Spotts, Project Director for the San Diego City College Redevelopment Project, presented the Staff Report.

Chuck Hope presented the Design Proposal for the "B" Street Overcrossing.  
On motion of Member Bates, said proposal was approved.

RESOLUTION 73, authorizing the Executive Director to advertise for bids for the demolition of structures for the San Diego City College Expansion Project, was adopted on motion of Member Morrow.

A proposed Resolution, adopting Redevelopment Agency Policy No. 300-2, relating to the Owner/Tenant Participation Program for the Plaza Redevelopment Project, was presented.

George Simpson, Community Development Director, answered questions directed by the Members.

RESOLUTION 74, adopting Redevelopment Agency Policy No. 300-2, relating to the Owner/Tenant Participation Program for the Plaza Redevelopment Project, was adopted on motion of Member Landt.

RESOLUTION 75, consenting to a joint public hearing as provided for by Sections 33355 through 33359 of the Health and Safety Code of the State of California, and designating June 20, 1972 as the date for the joint hearing by the Redevelopment Agency and City Council of The City of San Diego, on the Plaza Redevelopment Project.

Jim Spotts, Project Director for the San Diego City College Redevelopment Project, presented the Staff Report on the Linda Vista Study.

On motion of Member Bates, said verbal report was accepted.


Clarence Pendleton, Director of Model Cities, presented the Staff Report on Model Cities.
