Member Bates entered the Chamber.

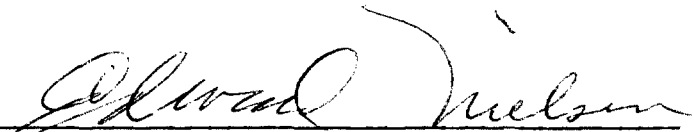
On motion of Member Landt, the Concept Plans were approved unanimously by the Members.
