

MINUTES OF THE ADJOURNED REGULAR MEETING OF THE

The Adjourned Regular Meeting of the Redevelopment Agency was  
called to order by Chairman Wilson at 5:56 p.m.

It was reported that this Meeting had been adjourned from Wednesday,  
January 2, 1974 to this time by the Secretary.

The Secretary reported that copies of the Notice of Adjournment  
covering the adjournment of this Meeting from Wednesday, January 2,  
1974 to 2:00 p.m., Tuesday, January 8, 1974, had been posted and mailed  
as required by law, and that the proper Certificates of Posting and  
Mailing are on file.

Minutes of the Regular Meeting of Tuesday, December 4, 1973, were  
presented by the Secretary. On motion of Member Johnson, said Minutes  
were approved without reading, after which they were signed.

Jim Spotts, Project Director for the San Diego City College  
Redevelopment Project, gave the Staff Report on the San Diego City  
College Redevelopment Project.

On motion of Member Bates, said report was accepted.

RESOLUTION 156, authorizing a first amendment to agreement between  
the City of San Diego, the Redevelopment Agency of the City of San  
Diego and the College District, covering the use and vacation of  
streets and utilities in the City College Redevelopment Project area,  
was adopted on motion of Member Johnson.

Jim Spotts, Project Director for the Linda Vista Shopping Center  
Redevelopment Project, gave the Staff Report on the Linda Vista  
Shopping Center Redevelopment Project.

On motion of Member Bates, said report was accepted.

Jim Spotts, Project Director for the Horton Plaza Redevelopment Project, gave the Staff Report on the Horton Plaza Redevelopment Project. On motion of Member O'Connor, said report was accepted.

The Members requested the Executive Director to instruct the Design Review Committee to work out procedures to allow for proper utilization of donated works of art or funds to be used for works of art.

RESOLUTION 157, authorizing the expenditure of not to exceed \$1,910 from Horton Plaza Redevelopment Project Fund 984 to Rockrise, Odermatt, Mountjoy and Amis (ROMA) for the printing of 1000 brochures on the Urban Design and Development Plan, was adopted on motion of Member Bates.

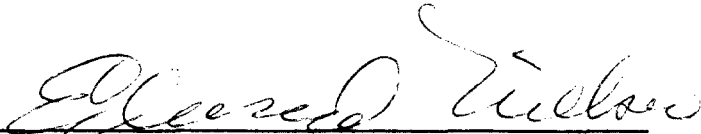
RESOLUTION 158, authorizing an agreement with Munroe & Reeves AIA for architectural, structural, mechanical/electrical services required to conduct a feasibility study of three structures in the Horton Plaza Redevelopment Project; authorizing the expenditure of not to exceed \$20,000 from Horton Plaza Redevelopment Fund 984 for said services and related costs, was adopted on motion of Member O'Connor.
