Item 2: Approval of the minutes of the Regular and Joint Meeting and Public Hearing of March 26, 1985.

Motion by Gotch to approve the minutes. Second by McColl. Vote: 7-0

Member Martinez entered the meeting.

Item 3: Resolution approving the basic concepts for the Front and "F" Street Building.

Gerald Trimble requested that this item be continued to April 23, 1985 in order to comply with a verbal request by officials of Ernest W. Hahn, Inc.

Craig Beam, representing Terry Nash, spoke in opposition to the continuance. Richard Burt, representing the Meridian Group, requested that the continuance be granted.

Motion by Martinez to continue this item two weeks to April 23, 1985 at 10:30 a.m. in the 12th floor Council Chambers. Second by Jones.

Chairman Hedgecock asked that the motion be amended to reflect that the sixty-day time limit cited in Section 706 of the DDA between Horton Plaza Associates and the Redevelopment Agency begin with the notice dated March 20, 1985 which Gerald Trimble sent to Horton Plaza Associates. Member Martinez agreed to this amendment.
