Introduction of an Ordinance amending Chapter XI, Diagram Two, of the San Diego Municipal Code, by adding new text under the Planning Development Section relating to Decision Levels.

Adoption of a Resolution approving the College Area Public Facilities Financing Plan.

Subitem-H: (R-94-121)

Rescinding the existing development impact fees for the College Area Community; and establishing new development impact fees for all properties within the College Area Community as described in the College Area Public Facilities Financing Plan of June 1993.

Councilmember McCarty moved to adopt Council Item 336 Subitems A, B, D, G, and H and introduce Subitems C, E and F.

Pat Hightman, Redevelopment Program Manager, stated that all written and verbal comments presented today would be responded to in writing and available for anyone wishing to see them. She then introduced Paul Robinson and Harry Albers, both representing the San Diego State Foundation; Frank Walden of City Design, and Ron Smith of City Staff.

Ron Smith, City staff Project Administrator, gave the staff report.

Harry Albers, General Manager and Vice President of University Relations gave a brief history on what the Foundation tried to do.

Paul Robinson expressed his belief and that of a third party consultant, the Nattleson Company, that the only way this plan would work is through the redevelopment process.

Eleanor Herzman, property owner in the area, expressed concern regarding access off of Campanile to the proposed parking spaces.

Marjorie Campbell, resident of the area, expressed her opposition to this project and the opposition of the Home Owner's Association, of which she is a member.

Barbara Greene, also a resident and member of the Homeowner's Association, did not believe this was a proper project for redevelopment.

Pauline Graves expressed concern that all students, regardless of income or residency, would be eligible for the proposed student housing.

Kip Howard, developer, believed that the proposed project could not be built by private enterprise acting alone.

Tom Carter said he is a strong believer in the redevelopment process and agrees with Mr. Howard that redevelopment is the only way to have the facilities this great school needs.

Sandy Giverson, San Diego State student and representing 28,000 students, presented a resolution signed by students of SDSU stating that they believe that redevelopment will boost the economy and provide an improved setting befitting students and their relation to the community.

Michael Ashworth, SDSU student and former member of the Project Area Committee, said there is a need for a true college community where students can live together in an environment that is supportive to their university experience. There is a need for new business to bring economic revitalization and necessary commercial services conducive to the needs of the university community.

Ms. Gallagher, executive member of the College Area Community Council, secretary of Community Affairs, and SDSU student, believed that the people most affected by redevelopment will be the students and that they should be able to live in a community of university students. She believed that the best way for them to receive this is through redevelopment.

The meeting adjourned at 12:00 noon.

The meeting reconvened at 2:00 p.m, with all members present.

Ron Smith continued with the staff presentation.

Frank Walden of City Design presented slides and gave a summary of current planning concepts developed by the community, City, Agency and Foundation.

Rich Robinson, representing the County of San Diego, and speaking in opposition, asked that this plan not be adopted, pointing out that the County believes that it meets none of the tests to make it eligible for redevelopment.

Norman Self, secretary of the College Area Community Council and Director of one of the religious centers located in the proposed redevelopment area, urged Council support for the redevelopment project, stating that they believe this is the community's best hope to reverse the degradation of the neighborhood, to address the blight and decay that characterizes part of this community.

Dorothy Leonard, speaking in support of the project for the Cooperative Campus Religious Centers and as a graduate of the old Campus Lab School, said there is blight and a great need to make improvements in the area.

Barbara Barrow, Alumni Director at San Diego State and representing both the Alumni and the Associated Board of Directors, presented a resolution passed by both groups stating that this redevelopment proposal offers the

potential for major improvements in campus life and would provide for the upgrading and beautification of the unsightly area immediately south of the University and expressed strong support for the project.

Robert Trovaten, member of the Project Area Committee and representing the fraternities on the committee, believed that the College area should be a statement to County residents and visitors coming into San Diego of what the City and County really are and what they have to offer. He said there is a great deal of blight in the area and urged the Council to approve this project.

Virginia Philp, representing one of the sororities on campus, said security for women on campus and off is a major concern. Through redevelopment, the women can be together in a separate area in an environment where there can be safety in numbers.

Anthony Navoy, resident in the area for 34 years and representing the College Area Community Council, expressed concerns related to the completion of the EIR Report. San Diego State, being a commuter university, makes traffic the most critical of concerns with no new access to handle the load. He believed that the costs of developing another access should be shared jointly by Redevelopment, State and Federal governments.

Gary Debusschere, Vice Chair of the College Area Community Council, said thousands of hours have been spent by volunteers concerning this project and they believe they have a quality project with the goal of building an urban village for which citizens of San Diego can be proud.

Alice Buck, Chair of the Project Area Committee, said she has been working on this project for six years and they have worked long and hard to bring this into being and she asks the Council support this plan.

E. James Boggus, homeowner adjacent to San Diego State and a PAC member, CACC Executive Board member and an Alumni, said this project would provide for Greek housing improvements which would not otherwise be possible. Mixed-use business will provide improved services for the students, student apartments will provide a choice for students wishing to live adjacent to the University, but not in dorms and the elimination of the deteriorated property will help the community as a whole with an improved quality of life for both the residents and student.

Member McCarty pointed out that everyone had worked very hard on this and believed that as the project area is now, it is a thorn in the side of the community and that redevelopment is an effort to make this a better place to live for the community and the students at the University. She also pointed out that Waring Road is the number one priority in making this work, as there must be an alternative access to this community.

Meeting adjourned into closed session at 3:25 p.m.

Meeting reconvened at 3:52 p.m. with Members Wolfsheimer, Roberts, Stevens, Behr, Stallings, McCarty, Vargas and Chair Golding present. Member Hartley not present.

Member McCarty moved to add to her original motion that the Facilities Plan be approved, to go ahead and approve sub-items G and H, but direct staff, with respect to the Facilities Plan, to move Waring Road to number one priority and the library to number two and the College Avenue widening to the bottom of the list.

Charlene Gabriel replied to Member Roberts' concern regarding extension of the trolley to this area stating that this could be put in the financing plan, but without showing funding as yet.

Member Wolfsheimer felt this project was taking public monies to benefit the private sector, the University and the State and did not believe taxpayer's money should be used when it does not benefit the general public.
