Resolution approving termination of the Owner Participation Agreement and the Reimbursement Agreement with DP Partnership, for failure to finance the public improvements required by the Owner Participation Agreement.

Patricia Hightman gave the staff report pointing out that they have gone through numerous notifications to move forward and noted that the subject property is going through foreclosure at the present. The Agency would be interested in working with the new owners.

David Doll, representing DP Partners, spoke in opposition to the proposal to terminate the agreement, stating they had met with the redevelopment staff in late November when the intent to terminate the agreement was mentioned. DP Partners made themselves available to discuss this, but have not as yet had an opportunity to work with the staff to resolve this. They believe the differences could be worked out.

Member Roberts believed that one last attempt should be made to sit down with DP Partnership and work out any discrepancies and to be sure that the City discharges all its obligations and he so moved that this matter be continued until such time that this can be done.

Member McCarty seconded the motion.
