Patricia K. Hightman, Deputy Executive Director, Redevelopment Agency. She presented the staff report and a slide presentation of CIC Chronology of the Agreement.

Public testimony:

William Jones, President of Citylink Investment Corporation, talked about and presented the first phase of the proposed Urban Village, encompassing 7 1/2 blocks. Mr. Jones gave a brief background of the police station involvement working with city staff, Pat Hightman and the Police Department, the community.

Jim Cahill, Chairman of the Board of Citylink Investment Corporation, stated on behalf of the board, we are happy to be involved with this project. He thanked members of city staff, Mid-City Development Corporation, representatives from the Police Department, and residents of City Heights.

Toni Cutri, architect, Martinez, Cutri and McArdle, presented the design, site plans, elevations, and floorplans of the proposed project.

Howard Wayne, President of the Mid-City Development Corporation said the corporation strongly supports the proposed police station into this community.

Member Kehoe stated this proposed police station is the most significant city investment in the community of City Heights. This project will offer a resource to our youths in the gymnasium, resource to the activists in the community, and will be an important facility not only for City Heights, but the surrounding communities of the Mid-City area.

Ms. Kehoe thanked William Jones, the people of City Heights, City and Police Department staff, and the Mayor and City Council.
