Amend the Fiscal Year 1996 Redevelopment Agency Budget to reflect changes in revenue sources for the following redevelopment projects and study areas:

Item A. Amend the Linda Vista Community Center project budget, Fund 98504, to reduce the CDBG appropriation by \$143,500 and to add \$143,500 in sales tax funds from City Fund 10227; and

Item B. Amend the San Ysidro Redevelopment Study budget, Fund 98570, to reduce the sales tax appropriation from Fund 10227 by \$185,000 and to add \$185,000 in FY 1996 CDBG funds; and

Item C. Amend the North Park Redevelopment Study budget, Fund 98300, to reduce the sales tax appropriation from Fund 10227 by \$62,000 and to add \$62,000 in FY 1996 CDBG funds; and

Item D. Amend the Barrio Logan Redevelopment Project budget, Fund 98900, to reduce the sales tax appropriation fund 10227 by \$38,000 and to add \$38,000 in FY 1996 CDBG funds; and


