Tom Fat, representing New World Limited Partnership, a general partnership consisting of Frank Wong and family, which is proposing a new Mid-City Continuing Education Center at 54th and University, next to the shopping center. He said New World Limited Partnership owns the building that the Mid-City Continuing Education Center is currently occupying. And New World is competing with Citylink for the right to build a new education center for the San Diego Community College District. We are not here to oppose Citylink's Urban Village Master Plan for City Heights, in fact we support it. However, we disagree is the possible relocation of the Mid-City Continuing Education Center currently at 54th and University.

Public Testimony - in favor (Citylink Project)

Howard Wayne, current, past president, and boardmember of the Mid-City Development Corporation. He spoke in support of the redevelopment, and subsection D of the Citylink project.

Peter Maverick, a boardmember of the Mid-City Development Corporation, spoke in support of the Citylink project, and urge strong approval of the Mayor and City Council, the draft of the City Heights Village project. He recommended that the 54th and University corner, that City Council do a study to find out what the financial impact on that area would be with the continuing education center relocating to the Citylink project.

Debra Chamberlain, unable to stay, in favor of the project.

Karen Manly, lives in City Heights, urge the Mayor and Council to approve and support the residents on this proposal. She said we are very active residents and take responsibility for the quality of life in our neighborhood.

Linda Pennington, representing Azalea Neighborhood Association, stated that the association supports this project, and Citylink has worked with us for the last two years.

Valerie Huffman said lived in the neighborhood for the last 17 years, a very active volunteer both in the 3rd and 7th districts. She stated there is much blight, deterioration in this neighborhood, there are a lot of groups working in the community together, but we need this big project to turn it around and to revitalize the community.

David Watson, President of the Board of Directors, Mid-City Development Corporation, spoke in support of the staff recommendations, that this project is the coming together of city government, city manager office, the mayor's office, city council offices, private investments and the community.

Jay Powell, unable to stay, in favor of the project.

Michele Fergoda, Director of the Mid-City Development Corporation, stated everyone that came before her addressed the concerns and issues, and in support of this project.

Dave Nelson, unable to stay, in favor of the project.

Geri Striker, Chair of the City Heights Area Planning Committee, said members of the committee has worked together with William Jones, the city and other members of the community to develop Citylink, that this project be approve by this council and mayor. This project will allow the community to grow and bring new businesses into this area.

Public Testimony - in favor (Citylink Project)

Councilmember Kehoe asked Tony Cutri to display the map of the City Heights area, gave brief overview of the proposed project. She thanked the community, city staff, and William Jones, stating that this project is very important to the City Heights community. Councilmember Kehoe said City Heights is one of the most densely populated areas of the City, with a population of over 70,000, 40% of the residents in the community live below the poverty level. In the past 40 years, City Heights has gone from being a neighborhood, which is primarily owner occupied to one which is now over 70% renter occupied. She a brief background of the infrastructure of City Heights, report from the Economic City Heights Economic Summit.
