Public Testimony - Opposition

Manuel Mancesa, representing the Coalition for the Chicano Parks Community Art Center. He said the community is divided, and the RFQ process be reopen so that we can come forward with other projects that will unite this community.

Mario Toreo, Chicano Park Artist from the community, spoke in opposition that there is no community center service in the proposed area for the artist and the community.

Maria Moya, had concerns about the noise and acholic that goes with the night activities, and does not belong in a residential area.

Deputy Mayor Wear chaired the meeting at 11:15 a.m.

John Lemo, representing the Mental Health coalition, spoke in the opposition for staff to enter into the exclusive negotiation agreement with Senor Chuey's project, but do support the development of the trolley site. Mr. Lemo distributed a letter.

Francesca Jimenez had Councilmember Vargas translate for her. Ms. Jimenez said we need an alternative for our children because there are problems with drugs and acholic. That there is a better project for the area.

Letia Ayala spoke in opposition to the proposed project, that this project is not good for the community, and reopen the RFQ process.

Sonya Rodriguez had Councilmember Vargas translate for her. Ms. Rodriguez said she is a mother, and this project will bring more acholic, more traffic, and violence into the community.

Christine Garcia said we have letters from Our Lady Of Guadalupe, Father Brown, the Continuing Education School, and others in support of this project.

Mark Bocca spoke in support of the Senor Chuey's project, that this project is an investment for the community.

Daniel Herendez said this project will unite the community.

Luis Garcia thanked the Mayor, City Council, staff and community for their involvement in this proposed project.
