David Allsbrook, project manager, Centre City Development Corporation, presented staff report and gave an overview on the relocation plan for proposed development of East Village. He explained several components of the redevelopment plan. One is to identify those that are affected by the proposed redevelopment. During the survey period, which took place between June and December of 1998, sixty-nine businesses and twenty-seven households were identified in that area that would be affected by the proposed redevelopment.

Public Testimony - Opposition

Laura Kim, resident of East Village and member of C.A.R.E. (Coalition Advocating Redevelopment Excellence), spoke in opposition of the approval and adoption of the relocation plan until the EIR is complete and certified so that the Redevelopment Agency will have the benefit of it's analysis.

Angie Walton, opposed, but unable to stay.

Christian Michaels, resident of East Village, spoke in opposition to the relocation plan. He is opposed to the removal of historic buildings and the community in the area in addition to 40% of the suggested relocation sites are in Chula Vista and National City.
