Hope and Gateway Center West Redevelopment Project Areas; (2) directing the Auditor and Comptroller to record the \$892,371 as an interest bearing loan to the City of San Diego to be repaid as soon as practicable from tax increment or other appropriate revenues; and (3) authorizing a loan repayment to the City of San Diego in the amount of \$892, 371 with money coming from the Mt. Hope, Central Imperial and Gateway Center West Redevelopment Project Areas.


