**3. Agency Budget Amendment for the Crossroads Redevelopment Survey Area.**

(RA 2002-30)

1. Amend the Fiscal Year 2002 Agency budget to: a) reduce the appropriations of the College Grove Project Fund 98001 by \$215,000; b) increase the appropriations of the College Grove City Loan Repayment Fund 98005 in the amount of \$215,000 to allow for a loan repayment to the City (Fund 10227) from the College Grove Redevelopment Project Area; c) accept the loan of \$215,000 from the City from Fund 10227 (Contributions to the Redevelopment Agency) and the loan of \$100,000 from CDBG Funds - District 7 Special Projects to provide funds for the Crossroad Redevelopment Survey Area with the loans to be recorded as debt of the Agency to be repaid as soon as practicable from tax increment or other revenues; and d) establish necessary accounts and appropriate funds in the amount of \$315,000 for Agency and consultant staff costs and related expenses for the feasibility study of the Crossroads Redevelopment Survey Area.
2. Authorize the Executive Director to negotiate and execute consultant agreements with Rosenow Spevacek Group, Inc. (RSG) in an amount not to exceed \$146,000 and with Cotton Bridges Associates (CBA) in an amount not to exceed \$130,000 for purposes of studying the feasibility of the Crossroads Redevelopment Survey Area.


