S40 El Cajon Blvd. Medians-Crossroads Redevelopment Project. (District 7).

(RA 2005-40)

Subitem A. Make necessary findings and authorize the contribution of \$1.75 million from the Crossroads Redevelopment Project Area to the City for the purpose of financing the El Cajon Blvd. Median Improvements (CIP 39-234.0), contingent upon Auditors first certifying that funds are available.

Subitem B. Amend the Fiscal Year 2005 Redevelopment Agency Budget by increasing the Crossroads Redevelopment Project Area budget (Fund 98250) in the amount of \$1.75 million for the purpose of financing the El Cajon Blvd. Median Improvements (CIP 39-234.0).

Subitem C. Accept the transfer of \$200,000 to the Redevelopment Agency from Council District 7 CDBG Funds as an interest bearing loan to provide funds for plan adoption activities for the Grantville Survey Area.
