### **SUMMARY**

<u>Issue</u> - Should the Redevelopment Agency approve:

- 1. Second Amendment to the Agreement with Dyett & Bhatia for ongoing work to update the Community Plan, in the amount of \$470,000; and the
- 2. First Amendment to the Agreement with Project Design Consultants to complete a Master EnvironmentalImpact Report (MEIR) to evaluate the impacts of the proposed Updated Community Plan, in the amount of \$90,000?

Staff Recommendation - That the Redevelopment Agency approve:

- 1. Second Amendment to the Agreement with Dyett & Bhatia for ongoing work to update the Community Plan, in the amount of \$470,000; and the
- 2. First Amendment to the Agreement with Project Design Consultants to complete a Master EnvironmentalImpact Report (MEIR) to evaluate the impacts of the proposed Updated Community Plan, in the amount of \$90,000.

Maximum compensation will not exceed \$1,950,000 and \$343,750, respectively for each Agreement.

<u>Centre City DevelopmentCorporation Recommendation</u> - On December 17, 2003, the Corporation voted unanimously to recommend to the Redevelopment Agency the approval of the proposed amendments to Dyett & Bhatia's and Project Design Consultants' contracts, respectively.

Other Recommendations- None

Fiscal Impact - Funds are available in the FY 2003-2004 Areawide Community Plan Update Budget for this purpose.

### **BACKGROUND**

The proposed contract amendments advance the Visions and Goals of the Centre City Community Plan and the Objectives of the Centre City Redevelopment Project by:

- allocating resources to update the Community Plan, and;
- providing funds to complete the required environmental eview of the proposed plan.

The Community Plan Update is a comprehensive work effort to update the 1992 Centre City Community Plan, the Redevelopment Plan for the Centre City Redevelopment Project, Centre City Planned District Ordinance (PDO), and the Master Environmental Impact Report ("Master EIR"). The Corporation and its consultant team began work on the Community Plan Update in March 2002. The Corporation established a Steering Committee of business and community leaders as the primary forum for public in put to the Community Plan update process. Additionally, numerous stakeholder meetings and public workshops have been conducted.

The contract amendments proposed in this report are for the two main consultants responsible to complete the Community Plan Update: Dyett & Bhatia (planning) and Project Design Consultants (PDC) (environmental). The proposed amendments also include hourly rate adjustments and one additional consultant for the Dyett & Bhatia team (see Attachment1). The requested authorization would fund the completion of the Community Plan/Planned District Ordinance/Redevelopment Plan tasks and Master EIR, including printing and public hearings and adopted plans. It is likely that additional tasks to complete Focus Plans may be necessary following the certification of the EIR and adoption of the Plan and implementing ordinances, and additional amendment(s) to these Agreements may be necessary. Funds would be budgeted in the FY 04-05 Budget for that additional work.

Originally, the work program was laid out in phases that generally corresponded to fiscal years. The Community Plan Update was anticipated to take approximately24 months over three fiscal years. The work program is currently in the third phase and third fiscal year of work. The consultants have made progress on addressing a lengthy list of complex issues. To date, efforts have focused on data collection and analysis, forecasts, issue identification, statements of visions and principles, the development of alternatives, traffic modeling, and a draft preferred plan. The team is beginning to discuss potential implementation measures. Following acceptance of the preferred plan, staff and the consultant team will begin to develop amendments to the Planned District Ordinance, the Redevelopment Plan and the Master EIR as required by the California Environmental Quality Act (CEQA).

Because the Corporation budgets funds on an annual basis, a multi-year consultantwork effort means that amendments will be necessary over the life of the contract. The last contract amendments were approved in August 2002.

The following provides a summary of the financial status of the Agreement with Dyett & Bhatia and PDC, respectively:

### **DISCUSSION**

The projectis generally proceeding within the budget anticipated when the Agency directed staff to begin work in 2001. In fact, work that is currently underway (at the approximate midpoint of FY 03-04) is being paid with funds remaining from FY 02-03. The schedule has been somewhat delayed because the process is moving slower than had been anticipated and may result in funds being required in FY 04-05. Some reasons for this are:

- This summer, Steering Committee members elected to divide into subcommittees
  for discussion of specific issues (urban design, circulation/transit, economic
  development, arts & culture and neighborhood amenities) prior to evaluating the
  preferred plan. The consultant schedule assumed they would meet following
  endorsement of the preferred plan to discuss implementation issues;
- A desire by the Steering Committee members and/or subcommittees for specific analysis, in some cases resulting in the need to scope work and hire additional consultants separately;
- Additional subcommittee meetings and document review to reflect the high level of involvement by committee members;
- The addition of at least two public workshops, one required by new legislation that did not exist when the work was scoped; and
- Research on topics that were not known or anticipated to require consultant time
  when the work program was laid out, including issues related to the airport,
  unreinforced masonry buildings, future art facilities and transfer of development
  rights (TDRs).

The proposed contract amendments for Dyett & Bhatia and PDC provide adequate funds to complete all tasks associated with updating the Redevelopment Plan, the Community Plan and the PDO.

Dyett & Bhatia and Project Design Consultants were each selected afterparticipating in a Request for Qualifications process. Dyett and Bhatia is a certified MBE firm.

### Dyett & Bhatia

Dyett & Bhatia submitted a Work Force Report dated October 21, 2003, which indicates a total of 20 employees, of which 14 are female and 4\* are members of an underrepresented ethnic group.

  - (3) Asian Americans

The contractor's workforce analysis reflects no gender or ethnic under-representations.

## **Project Design Consultants**

Project Design Consultants submitted a Work Force Report dated December 9, 2002, which indicates a total of 178 employees, of which 51 are female and 41\* are members of an under-represented ethnic group.

  - (8) Asian-Americans
- (1) American Indian
- (9) Filipinos

The consultant's Work Force Analysis reflects under-representations as follows:

- African-Americans in engineering/architect and technical categories
- Latinos in the administrative support category
- Asian-Americana in the technical category
- Filipinos in engineering/architect category
- Women in the technical category

Project Design Consultants submitted an EEO plan, which was approved by the City of San Diego on January 14, 2003. This Plan is valid for a two-year period.
