SUBJECT: Agreement for On-Call Civil Engineering Services with Nasland

SUMMARY

<u>Issue</u> - Should the Redevelopment Agency approve the proposed Agreement with Nasland Engineering for on-call civil engineering services for an amount not to exceed \$250,000?

<u>Staff Recommendation</u> - That the Redevelopment Agency approve the proposed Agreement with Nasland Engineering for on-call civil engineering services for an amount not to exceed \$250,000.

<u>Centre City Development Corporation Recommendation</u> - On February 23, 2005, the Corporation is scheduled to consider the recommendation to approve the Agreement. The action by the Corporation and the vote will be reported to the Redevelopment Agency when the matter is considered.

Other Recommendations - None.

<u>Fiscal Impact</u> - Funds are available in the Fiscal Year 2005 Centre City Redevelopment Project Budget for engineering services.

BACKGROUND

In accordance with adopted Corporation policy, a Request for Qualifications ("RFQ") was issued for civil engineering consulting services for the next three years. Twelve firms responded to the RFQ and six firmswere short-listed and interviewed. The interviewpanel consisted of Board memberGil Johnson, David Allsbrook, Manager-Contracting and Public

Works, Roberto Saucedo, (formerly) Senior Project Manager-Public Works, Gary Bosse, Senior Project Manager-Construction, and Mo Sammak, City of San Diego Development Services Department. Three firms were selected to provide civil engineering services for the next three years. The three selected firms are Nasland Engineering, RBF Consulting and Rick Engineering. Nasland Engineering was the highest rated firm and therefore was selected as the Corporation's on-call civil engineering firm.

The following list provides a description of the initial scope of services for the on-call civil engineering firms:

- General Consulting Services
- Surveying and Mapping
- Planning, General Engineering Design and Processing
- Construction Administration
- Cortez District Street Lighting
- Tweet Street Park
- Island Avenue Pop-Outs, Phase II
- Reimbursables and In-house Services
