SUMMARY

<u>Issue</u> - Should the Redevelopment Agency approve the proposed Third Amendment between the Redevelopment Agency of the City of San Diego and Kane, Ballmer & Berkman for Legal Services?

Staff Recommendation - That the Redevelopment Agency of the City of San Diego (Agency) approve the Third Amendment to the Agreement for Legal Services by and between the Agency and Kane, Ballmer & Berkman (Third Amendment), Special Agency Counsel for \$60,000 for the Southeastern Economic Development Corporation related work and \$150,000 for Centre City Development Corporation related work for a total Agency contract amount not to exceed \$2,322,860.

<u>Centre City Development Corporation Recommendation</u> - On May 25, 2005, the Corporation Board of Directors voted unanimously to recommend approval of the Third Amendment.

Centre City Advisory Committee (CCAC) Recommendation - None.

<u>Fiscal Impact</u> - The funding for this Third Amendment was approved as a part of the Southeastern Economic Development Corporation's (SEDC)FY 04-05 budget and funds are available in the FY 04-05 Centre City and Horton Plaza Redevelopment Projects Budgets for legal services.

BACKGROUND

On December 3, 2001, the Agency authorized the Executive Director to execute a three-year agreement with KBB, Special Agency Counsel, for the provision of legal services to the Agency and its corporations for a total amount not to exceed \$1,500,000 (Agreement). The contract was allocated as follows: \$750,000 for the Centre City Development Corporation (CCDC), \$525,000 for the SEDC and \$250,000 for the Agency.

There have been two amendments to the original contract which included SEDC.

On September 2, 2003, the First Amendment to the Agreement was approved by the Agency for \$160,000 for SEDC redevelopment project areas.

DISCUSSION

The City Attorney's Office will shortly be issuing a new Request for Qualifications for special legal counsel services for the next three-year period. Because the selection process will take at least several months to complete, additional funding is requested for on-going legal services until the selection process is completed.

The following provides a summary of the financial status of the Agreement for CCDC related legal work:

Upon arrival of SEDC's portion of the proposed Third Amendment, the total contract amount for SEDC related work is \$857,860. This amendment provides the funding necessary to continue SEDC's implementation of projects located throughout the SEDC Area of Influence as approved in the FY 04-05 budget.

The Scope of Services includes legal assistance in the negotiation and preparation of development agreements, assistance with redevelopment plan adoptions and amendments, consultation on significant redevelopment matters and coordination with the City Attorney's office.

There are no subconsultants associated with this Agreement.

EQUAL OPPORTUNITY

This action increases the funding for the third year of the agreement, therefore no equal opportunity outreach was done. KBB was selected after participating in a Request for Qualifications Process. KBB is not certified as a M/W/D/DVBE firm.

KBB submitted a Work Force Report on January 20, 2004, which indicates a total of 27 employees in their Los Angeles office, of which 15 are female, and 13 are members of an under-represented ethnic group.
