Counsel ("Condemnation") Services with the Law Offices of Donald

Detisch - Centre City Redevelopment Project

<u>SUMMARY</u>

<u>Issue</u> - Should the Redevelopment Agency approve the proposed First Amendment to the Agreement with the Law Offices of Donald Detisch?

<u>Staff Recommendation</u> - That the Redevelopment Agency approve the First Amendment to the Agreement for Special Legal Counsel ("Condemnation") services with the Law Offices of Donald Detisch ("Detisch") for \$100,000. The maximum compensation will not exceed \$350,000, of which \$100,000 is designated for Corporation related work.

<u>Centre City Development CorporationRecommendation</u> - On September 21, 2005, the Corporation Board of Directors voted unanimously to recommend approval of the First Amendment.

Centre City Advisory Committee (CCAC) Recommendation - None.

Other Recommendations - None.

<u>Fiscal Impact</u> - Funds are available in the Fiscal Year 2006 East Village Redevelopment District Budget and the Low and Moderate Income Housing Fund for legal services.

BACKGROUND

In October 2000, the City Attorney's Office issued a Request for Qualifications ("RFQ") for condemnation legal services for the next three years (2001-2003). Three firms were selected to provide services through the RFQ process; Detisch, Best Best & Krieger and

Daley & Heft. Last fall, the City Attorney's Office issued an RFQ for the next three-year period (2005-2007) and the same three firms were selected plus Kane Ballmer & Berkman.

Detisch was assigned all of the eminent domain legal work for the 12th and Market Block and the acquisition of abutters rights for the Park to Bay Project, and most recently, the litigation concerning the Yale Hotel under the 2001-2003 contract.

The purpose of the proposed Amendment is to provide funds for the on-going litigation concerning the loss of business goodwill in the Valu Mart case, the last remaining case from the 12th & Market Project, and the Oak Shelter Project.

At the request of the City Attorney's Office, it is recommended that the 2005 Detisch contract be amended to include this continued scope of work.
