### **SUMMARY**

<u>Issue</u> - Shall the Committee recommend to City Council the allocation plan described in
this report for funding the Priority Projects on the Coastal Infrastructure and Facilities
Needs List with Transient Occupancy Tax (TOT) funds?
Manager's Recommendation - Approve the funding plan for the priority project list
attached (Attachment 1).
Other Recommendations - None.

Fiscal Impact: The recommendation is based on \$1,638,038 in TOT funding allocated to the FY02 Coastal Infrastructure and Facilities Fund and \$130,000 in TOT funding allocated to Coastal Infrastructure-Council District 1.

# **BACKGROUND**

In June 1997, during the FY 1998 budget hearings, the City Council created the Coastal Infrastructure and Facilities Fund to address critical coastal erosion needs identified in a 1993 study of erosion sites along the coastal line as well as other infrastructure and facilities needs; the former being street end structures and utilities and public walkways, and the latter being buildings such as lifeguard stations, shower facilities and comfort stations. (See Attachment 2, memorandum from Councilmembers Harry Mathis and Byron Wear dated 6/18/1997 for additional background.) Each year a priority list is selected that includes both coastal erosion protection projects and repair/replacement of coastal facilities. Projects to be funded are reviewed and evaluated by the City Council's Natural Resources and Culture Committee before being sent to the full City Council for approval.

## **DISCUSSION**

The Engineering and Capital Projects Department maintains a list of coastal erosion sites and existing coastal facilities, and it is reviewed yearly for the purpose of proposing sites for funding. In addition, the Park & Recreation Department maintains a list of coastal facilities in need of capital improvement. Finally, as noted in a companion report on Lifeguard Facilities, additional needs come from the Lifeguard Facility Improvements. A primary goal has been to identify projects where funding has already been initiated and where supplemental funding would result in a completed project. In addition, the priority list includes projects that are in need of maintenance and/or replacement. Attached is this year's priority list for the committee's review and approval.

# **ALTERNATIVE**

Recommend a different list of priority projects.
