SUMMARY

<u>Issue</u> – Should the City Council and the Redevelopment Agency approve the First Amendment to the NTC Park Improvement Agreement and authorize the City Manager, or his designee, and the Executive Director of the Agency, or his designee, to execute the First Amendment to the NTC Park Improvement.

<u>Manager's/Executive Director's Recommendations</u> – That the City Council and the Redevelopment Agency approve the First Amendment to the NTC Park Improvement Agreement and authorize the City Manager, or his designee, and the Executive Director of the Agency, or his designee, to execute the First Amendment to the NTC Park Improvement Agreement.

Other Recommendations - None.

<u>Fiscal Impact</u> – The completed park will have annual operations & maintenance costs that are presently not included in the City Managers multi-year financial plan.

BACKGROUND

The Redevelopment Agency ("Agency") and McMillin-NTC, LLC ("McMillin"), entered into a Disposition and Development Agreement (the "DDA") in June 2000. The purposes of the DDA include effectuating the Redevelopment Plan for the Naval Training Center Redevelopment Project, adopted by the City Council in May, 1997, and the Naval Training Center Reuse Plan, adopted by the City Council in October, 1998, by providing for, among other things, the redevelopment of the property by McMillin and/or one or more assignees. The DDA contemplates the development of a mixed-use project involving the construction and installation of public infrastructure improvements, the rehabilitation and reuse of existing buildings and construction of new buildings and improvements, as well as the development of a public waterfront park and recreation area on City-owned property.

DISCUSSION

The NTC Park Improvement Agreement provides for the public waterfront park at NTC/Liberty Station to be developed in three phases, as follows:

As a condition of City Council approval of the issuance of Community Facilities District private placement bonds ("CFD bonds"), McMillin has committed to commencing and completing the park improvements on an accelerated schedule. Pursuant to the proposed First Amendment to the NTC Park Improvement Agreement (Attachment 1), if the CFD bonds are sold, the park improvements will commence and be completed on the following schedule:
