SUMMARY

This is an information item only. No action is required on the part of the Committee.

BACKGROUND

The San Diego Police Department presents reports to the Committee on index crimes and other crimes on a quarterly year-to-date basis.

This report summarizes January through June 2006 index crimes, as well as domestic violence, gang violence, hate crimes, juvenile crimes, and traffic incidents. Index crimes include murder, rape, robbery, aggravated assault, burglary, larceny, and motor vehicle theft. The Department of Justice Uniform Crime Reporting program collects information on these crime types from law enforcement agencies throughout the United States and uses the data to measure crime nationwide.

The total number of index crimes in San Diego decreased 2.9% in the first six months of 2006. There were 25,619 reported index crimes in January to June 2006, compared to 26,390 in the first half of 2005.

The total index crime rate per one thousand residents for the first half of 2006 was 39.08, compared to 40.42 for the same period in 2005. The annual index crime rates in previous years were 40.35 in 2004, 42.15 in 2003, 39.92 in 2002, 40.33 in 2001, and 36.30 in 2000, which was the lowest rate since 1966. As the following chart shows, overall crime rates decreased throughout the 1990's, and have shown a modest increase this decade.



Violent Crimes

Violent crimes – murder, rape, robbery, and aggravated assault – decreased 2.5% in January to June 2006. There were 3,140 violent crimes in the first half of 2006 compared to 3,219 for the same period in 2005. The rate of violent crimes per one thousand residents was 4.79, compared to 4.93 in 2005.


Of violent crimes, homicides showed the most significant increase. Homicides increased 56.5% in the first six months of 2006 with 36, compared to 23 in the same period of 2005. Rapes decreased 14.1% in the first half of 2006, with 159 compared to 185 in 2005. Robberies increased 8.6% in the first half of 2006, with 987 compared to 909 in 2005. Aggravated assaults decreased 6.9% in the first six months of 2006, with 1,958 compared to 2,102 in 2005.



Property Crimes

Property crimes -- burglary, larceny and auto theft – decreased 3.0% in January to June 2006. There were 22,479 property crimes in the first six months of 2006 compared to 23,171 in 2005. The rate of property crimes per one thousand residents was 34.29 in the first half of 2006, compared to 35.49 in the same period of 2005.

Burglary decreased 3.5% in the first six months of 2006 with 3,564 compared to 3,692 in the first six months of 2005. Vehicle thefts decreased 3.3% in January to June 2006, with 6,619 compared to 6,844 in 2005. Larceny, or theft, cases decreased 2.7%, with 12,296 in 2006 compared to 12,635 in the first half of 2005.



Clearances

The percentage of index crimes cleared during January to June 2006 was 14.0% compared to 15.1% in 2005. An offense is "cleared," or solved, by arrest or by exception. Clearance by arrest occurs when a suspect is arrested, charged, and turned over to the courts for prosecution. Clearance by exception occurs when the suspect is deceased, is already in custody, or is serving a sentence.

Police cleared or solved 45.1% of violent crimes during the first half of 2006, compared to 53.0% in the same period for 2005. The national average for violent crime clearances was 46.3% in 2004 (more recent data not yet available). Police cleared or solved 9.6% of property crimes in January to June, compared to 9.8% in the first half of 2005. The national average for property crime clearances was 16.5% in 2004.

Domestic Violence

The total number of domestic violence cases decreased 9.4% in January to June 2006, with 4,298 compared to 4,746 in 2005. Criminal cases decreased 8.8%, while the number of domestic violence calls that did not develop into crimes decreased 11.7%. Domestic violence cases involving firearms decreased by 25.0% from the first half of 2005 to the same period in 2006. Cases involving knives or cutting instruments increased 5.6%.

Gang Crimes

Crimes attributed to gang members decreased 9.9% in January to June 2006, with 354 cases compared to 393 in the same period of 2005. Nine of the 36 homicides in San Diego were attributed to gang members, a 12.5% increase compared to eight gang homicides in the first half of 2005. Attempted homicides remained stable with four in the first half of both 2005 and 2006. Assaults attributed to gang members increased 4.7% with 111 in the first half of 2006 compared to 106 during the same period in 2005. Robberies attributed to gang members increased 24.2%. Auto thefts attributed to gang members decreased 27.8%. Shootings attributed to gang members increased 8.0% and gang related stabbings decreased 9.5%. Drive by shootings decreased 45.0%, from 20 in the first six months of 2005 to eleven in 2006. Arrests of gang members decreased 18.1% from 962 in 2005 to 788 in 2006.

Hate Crimes

The total number of hate crimes decreased 4.2% to 23 in January to June 2006 from 24 in the same period of 2005. Hate crimes based on ethnicity accounted for fourteen cases (60% of the total), followed by sexual orientation with five cases (21.7% of the total) and religion with four cases (17.4% of the total).

Juvenile Crimes

The number of juvenile victims of violent crimes decreased 5.5% during the first six months of 2006, compared to 2005. Juveniles became victims of homicide seven times during the first six months of 2006 compared to twice during the same period in 2005. Arrests of juveniles decreased 21.0%, with misdemeanor arrests accounting for the largest portion of arrests during the day and after school hours.

Traffic Incidents

The number of collisions increased 0.4% in January through June 2006 with 5,575 in 2006 compared to 5,598 in 2005. There were 33 fatal collisions in the first half of 2006, resulting in 35 deaths. The number of DUI arrests increased 7.6% and DUI collisions increased 14.9% in the first six months of 2006 compared to 2005. Total Citations issued decreased 12.0% in the first half of 2006 compared to the same period in 2005.

Command Initiatives

Traffic Division coordinates the "Avoid the 14" grant, which funds a cooperative, countywide effort by fourteen local law enforcement agencies to combat drunken driving and other alcohol related violations. More than fifteen alcohol enforcement details involving Vice and Traffic Division were conducted during March through June 2006. Operations included four DUI checkpoint details, seven Minor in Possession sweeps, three college area enforcement details and a DUI warrant sweep. Traffic Division personnel are currently working with local DMV investigators and Probation officers to identify repeat drunken driving offenders.

The Central Division Neighborhood Resource Team commenced operations on January 18, 2006 with the purpose of working closely with the community on quality of life and crime related issues. Locations with narcotics activity, gang activity, loitering, graffiti, transients, abandoned properties, and chronic drunkenness are targeted by the team. The team has made over 1,700 misdemeanor and felony arrests, obtained 40 stay away orders, and coordinated 30 ongoing projects. A representative project that has been completed is 1600 Logan Avenue. The property was the location of an abandoned warehouse and adjacent house that consumed a high level of police services. In order to change the environment, officers contacted the property owner, informed the owner of the situation and obtained a letter of authorization to enforce all laws on the property. The enforcement effort eventually led to demolition of the buildings, cleanup, and secured fencing around the property and 24 hour on site security. Police services have not been required at the property since.

Southeastern Division continues to target violence and gang activity as a high priority community concern. The Bay Vista Apartment Complex continues to be a target project, and the complex management has installed eleven functioning security cameras. The management has supplied the police department with real-time viewing software for the cameras, and has been very cooperative in supplying archived recordings when crime cases occur in the complex. Management has continued to progress on other improvements to the property, including installation of parking lot gates, installation of exterior lighting, new fencing for the grounds, etc. While additional improvements are still needed, violence at the complex appears to have begun to decrease.

Investigative Initiatives

The Sex Crimes Unit has initiated a Cold Case Team that is responsible to investigate cases that have Combined DNA Index System California State database (CODIS) hits. The team reexamines unsolved high profile or series related cases and has had a high level of success recently with the identification of four very violent predators. In all cases, the suspect brutally sexually assaulted the victims. The team expects to see a much more dramatic increase in suspect identification and prosecution as the offender DNA database continues to grow.

The Narcotics Task Force partnered with the DEA and the Mexican government on "Operation Gear Grinder". The operation targeted several Mexican manufacturers and distributors estimated to be responsible for more than 75% of the anabolic steroids seized in the United States. The enforcement action is estimated to have reduced 80% of the illicit supply of anabolic steroids to the United States. Eight Mexico-based manufacturers of anabolic steroids and 23 associated persons have been indicted on federal drug trafficking and money laundering charges. The operation was featured in Sports Illustrated (April 19, 2006).

The Narcotics Unit has been investigating several businesses that opened in San Diego as medical marijuana dispensaries. California Proposition 215 and Senate Bill 420 establish the limitations under which a medical doctor may prescribe/recommend use of medical marijuana, and under which a patient or designated caregiver may possess marijuana. The marijuana dispensaries are in violation of both federal and state law. Investigation of these businesses led to the simultaneous service of 21 search warrants throughout San Diego and fourteen arrests. Narcotics detectives seized several marijuana grows, bulk marijuana, marijuana candy bars and cookies, and other marijuana enhanced products. Additionally, cocaine, hashish, ecstasy, mushrooms and thousands of dollars in U.S. currency were seized. Several weapons were also recovered during the operation, including a stolen Smith & Wesson handgun and an M-16 assault rifle.

The Homicide Unit investigates murders, negligent homicides, officer involved shootings and suspicious deaths. During the first half of 2006, the Homicide Unit closed eight murders that had occurred in previous years. The unit recently reopened a 1991 case where a 63 year old man had been robbed, beaten and strangled to death inside his home. Similarities had been noted between the case and another case with an identified suspect that had occurred five days earlier in the same neighborhood. DNA testing had been inconclusive at the time, and the case had been set aside due to lack of evidence. Recently, a homicide detective reprocessed evidence for fingerprints and with further DNA testing was able to place the known suspect at the scene of the second homicide. The suspect is facing trial for both murders.

The Gangs Unit has worked with the City Attorney's Office to implement five gang injunctions within the City. A temporary injunction against the West Coast Crips targets 50 documented gang members and a hearing is scheduled to make the injunction permanent. The unit has also assisted Mid-City, Central and Southeastern Divisions in making gangs sweeps, resulting in over 100 gang related arrests. The Graffiti Strike Force investigates 100 to 130 graffiti cases per month, with 40 to 60 arrests each month, and has assisted the Homicide unit in identifying suspects in six homicide cases during the first half of 2006. The Violent Crimes Task Force

recently completed a project to cancel violent crimes that were ordered by the Mexican Mafia and carried out by street gangs. Thirty-one suspects were indicted in June, and all but two are in custody.

The Economic Crimes Unit is working proactively to educate citizens, businesses and other law enforcement personnel about identity theft, embezzlement, and other financial crimes. The unit has helped the San Diego Municipal Credit Union develop a public brochure on how to avoid becoming a victim of identity theft, and what steps to take if you do become a victim. The unit has utilized technology to provide reporting forms for businesses to report check fraud/forgery and embezzlement crimes online. This process change has freed patrol officers from taking reports from many of these establishments. The unit is currently designing online forms for reporting identity theft crimes. Development of these forms is in preparation for development and deployment of a real-time reporting database which can be quickly analyzed to triage cases and uncover crime series.
