## STAFF RECOMMENDATION:

<u>SUMMARY:</u> San Diego's Community Emergency Response Team (CERT) was called into action for the first time during the October 2007 Wildfires that devestated both the City and County. Since that time, we have achieved many accomplishments:

- Graduated one CERT and two Business Emergency Response Team (BERT) academies
- Conducted four Refresher trainings
- Established and executed new battalion team trainings
- Provided over 20 team meeting, training, and continuing education opportunities
- · Conducted community outreach through fairs, web sites, and presentations
- Created two new positions (Operations Manager and Instructor Manager) for uniformed personnel
- Revised final drills and trainings

#### New program guidelines:

- More expectations before Disaster Service Worker (DSW) card is earned Mandatory team participation, continuing education, and skills training
- More leadership from team leaders

Leaders keep track of training, team meeting hours, and send monthly reports to office

• Increased responsibilities for Liaisons

Liaisons are point of contact between CERT office and the teams Divided by Battalions, based on FD battalions

## Outcomes of new program guidelines:

- Increased communication between volunteers and CERT office
- Increased leadership and involvement from instructors
- Increased involvement from team members
- Identifying high-value volunteers and leveraging their contributions effectively
- Created pathway for exploring more ways to support FD and expanding our value to the City before, during, and after disasters
- Increased satisfaction among existing volunteers

## Looking ahead:

- Developing more partnerships with BERT customers and identifying ways to incorporate their assets during disaster responses (vis a vis, shelters, staging areas, communications) and non-governmental organizations (NGOs) that operate in San Diego
- Continue to grow community outreach efforts to underserved populations and open up dialogue about value of disaster preparedness
- Expanding the role of volunteers to support Fire-Rescue and the City
